Baseless allegations have been raised with the ulterior motive to mislead the people of Jaffna against Northern Power Company Ltd., falsely claiming the power plant located at Chunnakkam (Jaffna) is causing pollution of the wells located two to three km away from the plant.

"As Northern Power Company Ltd., we deny outright these baseless charges raised by parties with vested interests and not a single charge has been so far accepted by Courts. As all evidence presented to Court even points to another location as being the source of contamination, the company is not in any way liable for the said situation," MTD Walkers PLC Director/CEO Lal Perera said. Northern Power Co commenced construction work on the power plant in 2007 amidst the conflict situation when no company or individual was willing to even venture into the north taking all risks to provide much-needed power to the people of Jaffna. Generation commenced around May 2009 and a larger population which had suffered severe hardships for over 15 years had electricity in their homes. "We were the company at that time that contributed the major amount of power as there was no other source and Jaffna was not connected to the national grid till almost 2012. The company went through many hardships, especially with no road transport facility being available and having to transport all material and personnel by air or sea."

No evidence yet found by Govt.-appointed independent committee: MTD Walkers Plc CEO

There is no scientific evidence to prove accusations which link the Northern Power Co. Ltd. to the controversial water contamination issue in Jaffna even though baseless allegations have been made by parties with vested interests, Northern Power's parent company, MTD Walkers Plc, announced yesterday in Colombo.

Speaking at a media conference, MTD Walkers Plc Director/CEO Lal Perera stated that baseless allegations had been raised with the ulterior motive of misleading the people of Jaffna about the company, falsely claiming that its power plant, located in Chunnakkam, has led to the pollution of several wells located 2-3 km away from the plant.

COLOMBO (EconomyNext) - Sri Lanka's Northern Power Company (Pvt) Ltd, an independent power producer connected to the stat-run distribution grid said it did not dump waste oil to the ground as alleged by residents but sold it for cash.

The firm said alleged contaminated wells were two to three kilometres away from the plant in Jaffna's Chunnakkam area and in any case no waste oil was discharged to the ground.

The firm said in a statement that waste oil was sold for cash and used to fire furnaces and they would not dump it on the ground and forego potential revenues.

The firm said at one time there was an 'oil lake' in the region from an older state-run plant which was then covered in a landfill and grid substation built upon it.

The firm said no one knew what had happened to the oil and the matter had been mentioned in court as well.

Residents in the area had protested recently that the Nothern Power Company's waste oil was contaminating their well.

MTD Walkers, CEO, Lal Perera, facing tough questions from the press yesterday said power generation to the Jaffna peninsula by the Walkers-owned Northern Power Company (Pvt) Ltd had underscored the reputation of Walkers' power stations and delivery of electricity to Jaffna was now an ongoing service facility.

If as you say you had done your surveys and had expert input before you commenced power supplies, who and why does anyone have to object?, the CEO was asked.

'We are a Colombo based company. Our history goes back many decades. We established our credibility in all areas of our businesses; and our tender for power supply to Jaffna was accepted. You will also appreciate that before physical work commenced, our surveys and feasibility studies were done. The government accepted our feasibility reports and it was only after their determination that we had established our bona fides and forwarded expert reports, that we were permitted to commence our installation work, Perera said.

A three-day hunger strike was yesterday called off by residents of Chunnakam against alleged oil leakage from the Northern Power Plant (NPP) after their representatives were given assurances by government authorities that immediate remedies have been taken to address their issues.

The residents of Chunnakam, medical doctors and Public Health Inspectors (PHIs) collectively commenced a hunger strike on Tuesday in front of the Chunnakam Sivan Kovil demanding the immediate closure of the Northern Power Plant and urged the authorities to declare the region as a 'disaster zone'.

"Our representatives met Power and Energy Minister Champika Ranawaka, Disaster Management Minister John Amaratunga and the Prime Minister's Secretary and were assured that the Ceylon Electricity Board (CEB) will stop buying power from the power plant if it is causing the oil leakage," said Dr. Ganeshanathan Senthuran, one of the protesters.

EconomyNext - Sri Lanka's MTD Walkers rejected allegations its thermal power unit in northern Jaffna was releasing waste oil and polluting wells in the peninsula, calling for an independent probe into the contamination as well as a war-time oil spill.

MTD Walkers Chief Executive Lal Perera said the allegation against Northern Power Company was raised by parties with "vested interests" and that none had been so far accepted by courts or by any government authority.

"As all evidence presented to Court points directly to another location as being the source of contamination," he told a news conference. "The company is not in any way liable."

Hundreds of Jaffna residents have been protesting in recent days, accusing the power plant of being the source of their well-water pollution in the Chunnakam area of the peninsula. which depends largely on its limestone aquifer for drinking water and irrigation.

Jaffna gets rain only during the north-east monsoon during the winter months of the northern hemisphere.

Northern Power Co began generating power in 2009 just as the island's 30-year ethnic war ended and supplied Jaffna till 2012 when the national grid was reconnected.
